PAPERS ARE INVITED ON THE FOLLOWING TOPICS:

EPIDEMICS AND HEALTH INSURANCE
 For instance, modelling of the demographic and financial impact of HIV/AIDS, Avian Flu, etc.

2. RISK SHARING MODELS

For instance, scientific analysis of models for sharing risks between those who insure health risks (insurers) and those who provide the medical services (doctors), and techniques of managing such risks.

3. DEVELOPMENTS IN HEALTH CARE TECHNOLOGY
For instance, the relevance of national electronic health records to actuarial work, the impact

of genetics, the cost-benefit analysis of new medical technology, etc.

4. MEDICAL INFLATION

For instance, how to actuarially evaluate risks associated with cost drivers, etc.

5. SOCIAL HEALTH INSURANCE

For instance, the impact of long term demographic changes on social health insurance systems, the role of public-private partnerships in provision of medical services under a social health insurance system, etc.

6. TOPIC TEAMS AND OTHER TOPICS

Papers on Topic Team topics will be submitted to the Topic Team leaders for their consideration. Please see the topics at left under Colloquium Format.

7. OTHER

Any other topic that might be of interest to an international audience of health care actuaries will be considered. Papers that do not fit into the colloquium sessions may be published as part of the colloquium proceedings and possibly submitted to the ASTIN Bulletin for publication.

ABSTRACT SPECIFICATIONS

- All abstracts must be submitted in English.
- Abstracts must be no longer than 300 words.
- Use a concise title that reflects well the content of the paper.
- Do not include graphics or diagrams.
- Italicise scientific names.
- All abbreviations and acronyms must be fully defined with their first use.
- Capitalise all trade names.
- Overly commercial abstracts will not be accepted.
- Authors must advise if a paper has been presented at another event or published, and when.

SUCCESSFUL AUTHORS

- A full, formal paper is required.
- Full paper specifications will be provided
- Successful authors will be given 45 minutes to present their paper. PowerPoint slides are suggested but not mandatory.
- A discount of ZAR 1000 off of the Delegate Registration Fee is offered to successful authors.
